 Permission is hereby granted for a permit to move oversize vehicles or combination of vehicles and loads, exceeding Nebraska & County limitations in regard to dimension or weight which must of necessity use county roads to reach its destination.

All moves will be made during day light hours. No moves will be made on Saturdays, Sundays, holidays, or when roads become hazardous because of weather. Special permission will be extended for special occasions for movement on the above days. Sarpy County Highway Department ( 402 - 537-6906 ) will be notified twenty - four hours prior to the move and after the move is completed. Sheriff Department shall be notified of the time of the move. If the wide loads would disrupt traffic, call for escort from the Sarpy County Sheriffs Department.

**GENERAL PROVISIONS:** This permit is granted with the understanding that:

- (1) The applicant assumes all liability and responsibility for all property damages or personal injuries, which may occur in consequence of this movement. A certificate of insurance, of an amount sufficient to cover said damages, shall be deposited with the county. INSURANCE COMPANY \* \_\_\_\_\_
- (2) The applicant shall comply with all laws of the State of Nebraska and all rules and regulations of the Sarpy County Highway Department, which have been or which may be herein after adopted relative to the use of the roads for movement of special vehicles or objects. This permit is issued only on county roads that this department has responsibility.
- (3) This permit shall be carried in the vehicle to which it refers and shall be open to inspection by any police officer or authorized agent of Sarpy County Highway Department or State Officials.
- (4) Violation of any of the terms or conditions of this permit shall automatically revoke it and the penalty of the original limitations shall be applied.
- (5) The applicant shall be responsible for all trimming of trees and removal of the trimmings. Permission for trimming of trees that are not in the County Right of Way shall be obtained by the applicant prior to the move.
- (6) All signs along the route will be lowered or removed as needed by the applicant and will be replaced immediately and in the same condition prior to the move.
